

The map contains many lies and should not have been used as evidence



## COMMENTS

**Meter 1** This is a lie. The pipe to harmony Cottage is laid in the lane in the same trench as the pipe to Carne View and does not enter private land just after the meter.

**Meter 2** This is correct. Both pipes were laid after SWW refused to investigate the low water pressure reported at the same time as we did (probably 2012). They were not laid at SWW's expense.

**Meter 3** It is very doubtful if this is true in that it is much more likely that Wheal Maid is connected to either the pipe leading to Goon Farm or the pipe leading to Homestead.

**Meter 4** This is correct but, as SWW admit, Tailings End also have a connection to our pipe allegedly to their outside tap. SWW told me they had told Tailings End to modify their pipe work - Have SWW told them to and have they done so?

**Meter 5** I think this is correct but I have not been able to find the stop tap. The important thing is that there is a long pipe leading to Goon Farm which may well have a connection to Wheal Maid and may have leaks either on the pipe itself or the (allegedly) very small bore pipe leading to Wheal Maid (who complain of low pressure) Bearing in mind that the pipe leading to <u>our</u> properties has cost SWW £501,880 (less £32,523 we saved SWW by <u>insisting</u> they install a check meter which revealed a leak / illegal usage which we cured by forcing people to disconnect) in wasted water over the time we have lived here. <u>SWW must</u> connect a check meter on this pipe to see if this pipe is also costing the same £501,880.

**Meter 6** This is a definite lie. The pipe after SWW's check meter does NOT enter private land at Five Acres - it continues down the lane towards Goon Farm and enters private land there. It is correct that I locked it but but Dr Parry is lying when he states in his <u>defence</u> (Mr Layte did not seek permission before interfering and damaging SWW's apparatus by installing a padlock; and this act was a direct contravention of Section 174 of the Water Industry Act 1991) I did not damage the meter or its housing in the slightest. As it is very unlikely that Dr Parry inspected the meter himself I suspect that it was another SWW employee who told him (Richard Harrison?) but Dr Parry should not have relied on heresay in his <u>Defence</u>

**Meter 7** This is almost certainly a lie. It is much more likely the pipe does not enter private land at Five Acres but continues down the lane to The Homestead. The important thing is that this is a long pipe leading to The Homestead which may well have a connection to Wheal Maid and may have leaks on the pipe itself. I am told The Homestead complain of low pressure. Bearing in mind that the pipe leading to <u>our</u> properties has cost SWW £501,880 (less £32,523 we saved SWW by <u>insisting</u> they install a check meter which revealed a leak / illegal usage which we cured by forcing people to disconnect) in wasted water over the time we have lived here. SWW must connect a check meter on this pipe to see if this pipe is also costing the same £501,880.
